Our Legacy

The College, LLC, the Successor, Shaw College At Detroit sanctioned by Marc Stepp, UAW Advocate under the Leadership of Roy Shelton, PE, Ph.D. in alliance with more than 100 Engineers formerly associated with the Chrysler Corporation Highland Park MI, spearheaded the reorganization of the program known as "DAPCEP", and engineered, mastermind, and initiated 3 - D Design Concepts under the auspices of MeHarry College, LLC, School of Engineering; Research Development.

MeHarry College, LLC dedicated Faculty, organized and created an afterschool program, "The Kiddy College 'to serve the children of students enrolled and attending MeHarry College, LLC. While "Carolina's Early College", an Upper College Preparatory School served as the forerunner of the Historic Poly Gymnasium Preparatory Schools of the Lutheran Church.

The Kiddy College and DAPCEP initiatives introduced concepts of "S.T.E.M and Literacy" (Reading & Comprehension) as an extra curricula extension of MeHarry Allied Health Learning, Inc. which was organized in 1982.

Pursuant to Authority as granted by the U.S. Federal District Court MI; 1.9.1985, a Consortia was established as an extension of MeHarry College, LLC that comprised Marygrove College, and Lewis College of Business to create the College of Liberal Arts, School of Business, School of Nursing and Allied Health. The Leadership of Lawrence Tech actively participated in the Consortia to support organization of the School of Engineering as a Faculty of MeHarry College, LLC.

On November 5, 2003, in the State of Michigan, the Honorable Governor Jenifer Granholm issued an Executive Order sanctioning actualization of the Caroline Education Community International Public School Academy.

The Governor's Executive Order endorsed the organization of Caroline Education Community as a Public Charter School that advocated the introduction of Innovation Technological, as a provocative educational initiative within "Communities of Promise" in 18 Minority Communities throughout the state of Michigan.

Authorized, Caroline Education Community International Public School Academy (CECI PSA was Chartered in MI; 7.2.2003, featuring an elementary and secondary school, organized in response to the Mis-Education of K12 Minority Children enrolled, registered and attending Public Schools.

The school is named as a tribute to the Honorable Congresswoman Carolyn Cheeks Kilpatrick, and Carolyn Hatchett, Elder/Mother's Mission, Cathedral St. Augustine's.

MeHarry College, LLC is actualized as sanctioned by Authority of the Historic Great Lakes Lutheran Church University Education Charter; 1846. Caroline Education Community International Private School Academy is organized as sanctioned by the same inherent Authority, endowed as a Proprietary School Education Charter; 1892.

The elementary and secondary school actualized in tribute to the Historic *Polynomial* School initially organized by "the Other Rosa" who established more than 2,000 K-12 Schools throughout the Nation 1910 - 1912, including Michigan, Alabama, Mississippi, Missouri, Tennessee, New York, and Canada.
